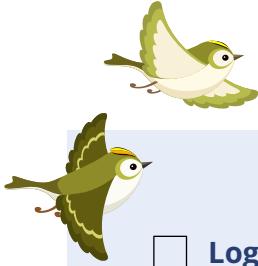

## Service Agreement for the No Sweat Nature Study Program

### I. Introduction

A. Parties Involved: The service provider (Our Journey Westward, LLC) and the parent(s)/guardian(s) of the enrolled child(ren).

B. Purpose: This agreement outlines the terms and conditions for the No Sweat Nature Study On-Demand access for children.

### II. Access Details

A. Description: No Sweat Nature Study On-Demand provides 10 months of video-only access to a library of more than 175 previously recorded, nature-based science classes. Each lesson includes nature journaling and optional enrichment resources such as nature walk ideas, hands-on activities, and kid-friendly research projects. High school extension projects are included for older or advanced learners. Live class access is not included with this version.

- B. Age Range: Lessons are designed for students in grades 1–8, with flexibility to accommodate a wide range of skill levels, including high school.
- C. Access Portal: Families can log in to their account at <https://ourjourneywestward.com/member-dashboard> to access the video library and additional learning resources.
- D. Program Length: Access begins on the date of purchase and continues for 10 months. Access will automatically expire at the end of the 10-month term. A reminder email will be sent prior to expiration, offering the opportunity to repurchase.

### **III. Payment Terms**

- A. Access Fee: The full cost of the On-Demand program is paid in a one-time transaction. There is no subscription or automatic renewal.
- B. Payment Methods: Payment by parents must be made in full at checkout using a valid credit card or approved purchase method. For charter or ESA purchases, prepaid access codes or purchase orders may be used.
- C. Charter/ESA Purchases: Families purchasing through charter or ESA funds may select the appropriate prepaid option at checkout or submit receipts for reimbursement if self-paying.
- D. Purchase Orders: Purchase orders must be submitted through the proper portal or via email. Access will be granted upon receipt of the order.

### **IV. Refund Policy**

- A. Refunds must be requested within 30 days of purchase and are subject to a 20% administrative fee. No refunds are granted after 30 days.

### **V. Intellectual Property Rights**

- A. Ownership: All content (videos, printables, activities, journal prompts, and extension projects) is the property of Our Journey Westward, LLC.
- B. Usage: Materials are licensed for use by one family only. Group use requires the purchase of a group license. Sharing or reproducing the materials without express permission is prohibited.

### **VI. Privacy and Data Security**

- A. Data Use: Basic account information is securely stored at [OurJourneyWestward.com](https://OurJourneyWestward.com). Administrators have access solely for support and management.
- B. Payment Security: Credit card information is processed through a secure WooCommerce Stripe gateway.
- C. Data Removal: Families may request the removal of their personal data by emailing [cindy@ourjourneywestward.com](mailto:cindy@ourjourneywestward.com) after their access period has ended.

## **VII. Technical Requirements and Support**

A. Requirements: An internet connection and a compatible device (computer, tablet, or smartphone) are required to access the video library and download materials. A printer may be helpful to print the vocabulary word list, the only downloadable learning resource.

B. Support: Please troubleshoot common issues using internet searches or your device settings. If needed, contact [cindy@ourjourneywestward.com](mailto:cindy@ourjourneywestward.com) for help.

## **VIII. Termination**

A. Expiration: On-demand access ends automatically 10 months from the date of purchase. If desired, customers may repurchase a new access term.

B. Violation: Our Journey Westward, LLC reserves the right to revoke access without refund in the case of material sharing, breach of agreement, or misuse.

## **IX. Governing Law and Jurisdiction**

A. Jurisdiction: This agreement is governed by the laws of the State of Kentucky, United States.

B. Disputes: Disputes shall be resolved first through mediation, and if necessary, arbitration in Kentucky.

## **X. Miscellaneous**

A. Severability: If any provision is found to be invalid, the remainder of the agreement remains in effect.

B. Entire Agreement: This document constitutes the full agreement between the parties and supersedes all prior discussions.

## **XI. Effective Date and Agreement**

A. Effective Date: This agreement is effective upon the date of purchase of On-Demand access. Purchase implies acceptance of these terms.
